

DAY 1 - USA - MUNICH

We board our international flight to Germany. Enjoy complimentary meals and beverages aboard the flight.

DAY 2 - MUNICH

We arrive in Munich, Germany. Upon arrival at the Bavarian capital, you will be greeted by your tour guide and driver at the airport. Enjoy a panoramic tour on the way to your hotel. Relax and settle in as you enjoy a welcome dinner with your fellow pilgrims.

DAY 3 - OBERAMMERGAU

Today we continue to Oberammergau, where the afternoon and evening are dedicated to world-famous *Passion Play*. This play is only celebrated every 10 years!

DAY 4 - OBERAMMERGAU - MUNICH

Today we will spend a leisurely morning in Oberammergau. In the afternoon, we will visit Marienplatz and explore its many enticing shops.

DAY 5 - FÁILTE (WELCOME) TO DUBLIN -**CLONMACNOISE - WESTPORT**

Today we board our flight to Ireland. Upon arrival in Dublin, you will be greeted by your guide. We will visit the monastic settlement of Clonmacnoise, one of Ireland's most celebrated holy places, where we see the 12th century round tower and ancient High Crosses, as

your hotel.

DAY 6 - WESTPORT: EXCURSION TO KNOCK & **BALLINTUBBER**

This morning we enjoy an excursion to Knock, visited each year by more than 1.5 million pilgrims. Upon arriving here as a pilgrim in the autumn of 1979, Pope John Paul II declared: "Now I am at the goal of my pilgrimage to Ireland!" We will enjoy a guided tour of the Shrine's grounds to learn the story of the apparitions here. We celebrate Mass then afterwards make our way to Claremorris, we visit Ballintubber Abbey where Mass has been celebrated daily for over 800 years! St. Patrick baptized converts at a well, and this was the traditional starting point for the annual pilgrimage to the Holy Mountain of Croagh Patrick.

DAY 7 - WESTPORT - BURREN - CLIFFS OF MOHER

Today we leave Westport and head south, passing through the mesmerizing landscapes of The Burren region. Its stone formations have lain unspoiled since the ice age. We stop at the town of Ballyvaughan for Mass this morning. We then drive to the Cliffs of Moher, sheer cliffs dropping 600 feet to the water below. We continue our journey to Killarney.

DAY 8 - RING OF KERRY & CRUISE ON THE LAKE **KILLARNEY**

This morning we join the local community in Killarney for Mass at St. Mary's Cathedral. Then we are off for a scenic ride around a portion of the famed Ring of Kerry. This afternoon we enjoy a relaxing cruise on Lough Leane, the most famous of the Lakes of Killarney. Dinner tonight is on our own to explore the local pub scene.

DAY 9 - CAHIR CASTLE - ROCK OF CASHEL

This morning we travel first to County Tipperary to visit Cahir Castle, one of the largest castles in Ireland, sited on an island in the River Suir. Construction of the castle began in 1142 AD by Conor O'Brien, Prince of Thomond. After our visit, we continue on to the Rock of Cashel. Possibly the most photographed site in Ireland, the Rock of Cashel is one of Ireland's leading tourist attractions. Here, in 450 AD, St. Patrick baptized King Aengus. We tour the ruins here, including Cashel Cathedral, still in very good condition given its age. Granted to the church in the 12th century, the Rock became the seat of the archbishop of Cashel. Today, impressive stone walls enclose a round tower, a cathedral, a 12th century Romanesque chapel, and high crosses.

DAY 10 - DUBLIN - GUINNESS STOREHOUSE

Today we enjoy a sightseeing tour around the city. We will see Georgian Dublin, visit St. Patrick's Cathedral (Church of Ireland), and also Christ Church Cathedral. We will also visit Trinity College, where the famous Book of Kells is kept. We celebrate Mass at Whitefriar Street Church. Afterwards, we enjoy a guided tour to the famous Guinness Storehouse.

DAY 11 - DUBLIN - GLENDALOUGH

We depart for Glendalough - the Glen between the Two Lakes, one of Ireland's most beloved early Monastic sites. According to legend, St. Kevin retired to this spot to be alone, living as a hermit for years. We celebrate Mass at St. Kevin's Church. We return to Dublin for the rest of the day at leisure.

DAY 12 - DUBLIN - USA

Today we board our return flight home. This concludes our services.

Documents:

US citizens require a valid passport. Other nationalities please inquire with the appropriate embassies. Passports must be valid for six months beyond the tour's return date. Travel Warning:

Please be advised that there is a Travel Warning issued by the Department of State and cancellation for this reason will not constitute grounds for refund of the cancellation fees listed below.

Registration and Deposits:

A deposit of \$400 per person is required upon registration along with a signed copy of the registration form. Registrations cannot be taken by telephone. Registrations are processed in the order received by HTI. Balance of payment is due 90 days prior to departure. Late payment is subject to a non-refundable \$150 late fee. Late registrations (fewer than 90 days) must be accompanied by full payment by cashiers check only (including the optional passenger travel protection program payment, if applicable), plus a non-refundable \$150 late fee and are subject to availability. HTI reserves the right to cancel reservations that are not paid in full 75 days prior to departure and to charge cancellation fee/penalties indicated below. A non-refundable \$25 fee will be charged on all checks and online payments returned by our bank. Changes In Package:

After initial invoicing, any change in package from air inclusive to "land only" or vice versa is subject to a non-refundable \$150 per person per change processing

Individual Cancellation Fees & Refunds:

All cancellations must be received by HTI in writing via following schedule:

1)\$250 if cancelled at any time up to 150 days prior to the tour's departure date;

2)\$350 if cancelled 149 to 90 days prior to the tour's departure date;

3)\$400 plus any non-refundable amounts paid to and/or penalties assessed by airlines, hotels, or other suppliers of travel services (up to the total cost of the tour) if cancelled 89 to 8 days prior to the tour's departure date;

4)No refunds for cancellations received within 7 days of departure date.

The above cancellation fees or/and penalties will also apply if you register for an optional extension or airline routing, and you decide to cancel or change any of these. HTI strongly recommends the Passenger Travel Protection Program (see Passenger Travel Protection Program info.) **Tour Operation & Cancellation:**

While no changes are anticipated, HTI expressly reserves the right to cancel all or any part of the tour or to make any changes to the itinerary, for any reason or whenever it deems it necessary for the comfort, convenience or safety of the tour participants. In the event of any alteration to the itinerary, every effort will be made to substitute the altered with a comparable replacement. If a tour is cancelled in its entirety by HTI, full refunds shall be issued within three weeks of such cancellation. This will constitute, in full, HTI's obligation to you and HTI bears no further responsibility beyond the full refund. HTI shall not be held liable and hereby expressly disclaims liability for any loss, expense, damage or inconvenience caused as a result of any tour cancellation or changes made to the itinerary. Furthermore, HTI is not responsible for any additional costs or fees relating to the issuance and/or cancellation of air tickets or other travel arrangements not made though.

Cancellation Beyond HTI's Control:

HTI expressly disclaims any responsibility for any losses or expenses incurred due to cancellation or alteration of the tour resulting from, but not limited to: cancellations due to travel advisories or warnings issued by the State Department or any other relevant authority, acts of war, war, terrorism, acts of God, natural disasters or any other circumstance beyond HTI's control. In such case, HTI will assist you in requesting refunds for all services prepaid but not rendered, less a non-refundable \$300 per person administrative fee. HTI shall not be held responsible for any non-recoverable amounts disbursed to carriers or other service providers on your behalf.

Passenger Travel Protection Program:

Passenger Travel Protection Program is offered by HTI and is strongly recommended. A Travel Protection Plan enrollment form consisting of a description of coverage provided will be mailed with your invoice. The plan fee is based on the tour price and taxes (as well as single room supplement and airline add-ons, if applicable) and will appear as an optional item on your invoice. Some benefits are time sensitive so we encourage all travelers to purchase a plan at the time of initial trip deposit. Travel Protection is non-refundable 14 days after purchase.

Participants who need such assistance must be accompanied by a qualified companion at all times and at their own expense. HTI assumes no responsibly for the participant's inability to fully participate in the tour, nor can HTI provide any refund for non-participation in any part of the tour.

Air Transportation:

All airline tickets are round-trip economy class and are non-refundable unless specifically stated otherwise. Any cancellation, itinerary changes, or failure to use confirmed space would be subject to penalties and/or fees levied by the airline at the time of ticketing. Airfare, airline carrier, and airline schedules are subject to change without notice. Passengers arranging their own flights are responsible for meeting the group at the first hotel of the group's itinerary. HTI is not responsible for itinerary changes necessitated by changes in the airline's schedule. Airline and cruise fuel surcharges and security fee surcharges (if any) that occur after the date of printing of the brochure are the responsibility of the passenger.

Deviations:

Deviations from the group flight itinerary are not possible. If you wish to make your own airline arrangements and purchase the 'land only' version of the tour package, please contact your group coordinator for the 'land only' pricing. Airline Seating, Frequent Flyer & Meal Requests:

Seating is on a group basis only. HTI cannot accommodate any individual request. HTI advises that you contact the airline for frequent flyer miles and special meal requests two weeks prior to departure. Baggage is at risk all times. We strongly suggest that you bring only one piece of checked luggage and one carry-on. Porterage is included at hotels only for one piece of luggage; the passenger is responsible at all time for carrying carry-on luggage. No porterage at airports.

Accomodations and Meals:

Based on double/twin accommodations with private bathroom facilities (limited number of single rooms available). No reduction for triple rooms. Triple room consists of twin/double room plus a rollaway bed, and confirmation is based on availability. If no roommate is available for you or your roommate cancels prior to departure, a single supplement surcharge will apply. Meals are menu of the day as shown in the itinerary.

Sightseeing:

By private motor coach with English-speaking guide/escort. Entrance fees included per final itinerary.

If group does not reach group size quoted in brochure, the price or programing will be adjusted accordingly. Pricing is based on exchange rates and fares applicable at the time of quotation and are therefore subject to change. Fuel surcharges subject to increase up to 30 days prior to departure.
